Further suggestions along with clarifications have already been filed. I thank Dr. K Shivaram, Madam Prem Lata Bansal, D. K. Gandhi, CA. Rajesh Mehta and Adv. V P Gupta for actively contributing in this presentation and compilation of suggestions.

All the members are made aware about the proposed lecture series on New Income Tax Act, 2025 started from 28th March, 2025 almost on all Friday between 05.00 pm to 07.00 pm with galaxy of faculties who are masters in the field. This series will deal chapter wise the entire New Income Tax Act, 2025. It shall end by 26th September, 2025. Till date eight episodes have been successfully completed with 1493 registrations.
