In partial **modification/clarification** to the Election Notice dated 31.10.2023 regarding eligible criteria as mentioned in Clause- 6B of Election Notice, the following modification/clarification is made in **overall interest of AIFTP**;

Existing members of the National Executive Committee who have not attended 50% of the meetings (Physical and Virtual) held or at least two meetings (Physical and Virtual) of the National Executive Committee whichever is less in a calendar year shall not be eligible for filing the nomination for the election for the terms 2024 & 2025 of AIFTP.
