1. The candidate should be a Life Member of the AIFTP at least last two years as on Saturday, 18<sup>th</sup> October, 2025 and should have been in practice for more than 5 years, as on Saturday, 18<sup>th</sup> October, 2025 while the **proposer and seconder may be a Life member or an Association member duly nominated by the Association.**
2. Last date for receiving nomination form at Mumbai is **Tuesday, 25<sup>th</sup> November, 2025 upto 5.00 PM** at Registered Office, Mumbai addressed to the Chief Election Officer for the terms 2026 and 2027 of AIFTP.
3. The election, if necessary, will be conducted as per the prescribed Election Rules of AIFTP on **Friday, 12<sup>th</sup> December, 2025 from 02.00 PM to 07.00 PM at Tennis Pavilion, Bengaluru Palace, Bengaluru (Karnataka).** Candidate must be present at the time of election, however, the Chief Election Officer may grant exemption of personal presence during voting, if any, due to exceptional circumstances only provided request is made by the candidate before 72 Hours of the voting but not later than 24 hours of the voting.
4. The Chief Election Officer on finalizing the list of contestant/s, shall cause to publish an abridged bio data of each candidate, alphabetically arranged, by email (or by any other electronic or digital means) to every member as also upload it on the official website of the Federation at least 7 days i.e. Friday, 5<sup>th</sup> December, 2025 in advance of the actual election date i.e. Friday, 12<sup>th</sup> December, 2025, and it shall remain on the said website of the Federation till the election process is over. The Candidates are advised to submit bio-data in soft copy which should state and contain in 200 words [full filing Column (d) as given below] only addressed to the Chief Election Officer with the following Details:
  - (a) Latest passport size photograph
  - (b) Qualifications;
  - (c) Brief description of any disciplinary proceedings instituted in the past and closed;
  - (d) His / her experience with other association/s and importantly his contribution to Federation activities;
5. All nominations have to be accompanied by a payment of Rs. 5,900/- (Rupees Five Thousand Nine Hundred Only) (Including 18% GST) payable to the AIFTP's Account preferably via NEFT to an AIFTP's account or a Cheque drawn of said amount, which shall not be refundable except in case of withdrawal of candidature within the time prescribed, wherein an amount of Rs. 2,000/- (Rupees Two Thousand Only) shall be refunded and the rest amount of Rs. 3,900/- shall not be refunded and/or forfeited.
